The Charlotte Valley Central School District received bids for this project on Wednesday, September 14, 2022. A Tabulation of the Bids is attached.

Hunt, in conjunction with Schoolhouse Construction Services has reviewed all bid forms and the qualifications of the low bidder for the Contract noted below. Bids were received for a single prime General Contract. Based on our review and conversations with the School District we present the following summary of information for the Board of Education's review and action.

A. SUGGESTED CONTRACT AWARD

Contract #101 – General Trades Work:

Eastman Associates General Contractors 6 Railroad Ave. Oneonta, NY 13820

Total Recommended Contract Award	\$73,650
Base Bid Alternate #2 (Flooring replacement in Room 186)	\$49,450 \$24,200

B. OTHER CONSIDERATIONS

Bid Alternates: Bid alternates were also included in consideration. We recommend the Board award Alternate #2 as listed listed above and not award alternate #1 or #3 at this time.

Alternate ALT #1 - \$24,000 (Flooring replacement in Room 183)
Alternate ALT #3 - \$28,400 (Flooring replacement in Corridor C116 & C117)

Please note that the bidding documents allow the Board to accept or reject alternate prices up to 60 calendar days following the closing date for bidding.

C. UNIT PRICING

Unit Prices: Unit Pricing was requested for this project. All Unit Pricing was reviewed by HUNT and Schoolhouse Construction Services and found to be acceptable.

D. BUDGET SUMMARY

E. CONCLUSIONS


In conclusion, we suggest that the Charlotte Valley Central School District take the following action at the next Board Meeting:
