We were remote before the holiday but continued to play sports. How can it be safe to play sports and not safe to be in class.

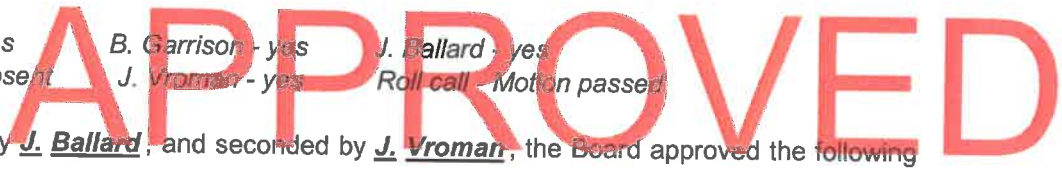
No accountability for bad behavior.
