Smart School project

Thank you to everyone for a successful fall sports season.

The state is putting forth a major initiative for electric busses. The initiative calls for school to have at least on electric bus lease by 2027 and the entire fleet switched over by 2035. We have three options. One is to do nothing for now and 2 is to study the implications of electric bus fleet transition. 3 is to go get an electric bus as soon as possible. Mr. Whipple's recommendation is option 2 so that we are able to make informed decisions in the future.

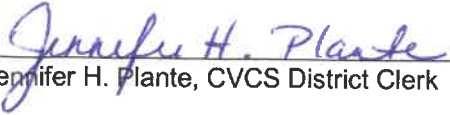
